"The Alternative Governance Plans for the 34 Kentucky public schools that were listed in No Child Left Behind TIER 5 status in the 2008 reports...In addition, copies of any presentations and reports on corrective actions and progress being made in these TIER 5 schools. Such presentations and reports could include, but are not limited to, those for: legislative committees and agencies, the Kentucky State Board of Education and federal oversight entities."


We do not have "Alternative Governance" plans. We do have "Restructuring Plans". Attached are those plans that were submitted by districts last spring.
